

TERMS AND CONDITIONS FOR LITTLE DISH COMPETITION

1. This document sets out the rules for this competition. Make sure you read them carefully and understand them all before you enter the competition. By entering, you promise to follow and be bound by these rules.
2. Remember to get your parent's or legal guardian's permission before entering the competition. Once they give you the go-ahead, you can enter the competition by going to www.nickjr.co.uk, following the link to the Little Dish competition and answering the multiple choice question. Costs to enter competitions online may vary so don't forget to ask the person paying the bill for their permission to enter this competition.
3. The closing date for entries is 11:59 am on 21 September 2009. Any entries received after this time will not be valid, so make sure you enter on time!
4. To enter this competition, you must live in the UK and you must be aged fifteen (15) or under. Sorry, but you are not allowed to enter if anyone in your immediate family (ie your parents/legal guardians, brothers or sisters, grandparents, aunts, uncles or first cousins) work at Viacom Brand Solutions Limited ("**VBS**"), MTV Networks Europe, Nickelodeon UK Limited ("**Nick UK**") or Healthy Kids Limited or any agencies involved with the competition or any companies connected to any of these companies.
